### EAFIP – Second Major event in Innovation Procurement, Athens, October 2016



The second major eafip event took place in the National Centre for Public Administration and Local Government (EKDDA) in Athens, Greece on the 18th and 19th October 2016. This two-day event targeted procurers, policy makers, procurement law firms and businesses, to raise awareness about major PCP/PPI initiatives across Europe, explain the progresses made this last year, present the final version of the eafip Toolkit of assistance, and discuss new ideas, initiatives and funding opportunities for PCP/PPI.
